2018 ANNUAL MEETING MINUTES (as promised at the 2019 Annual Meeting)

The Annual Reunion and Meeting of the Manning Association Stockholders was held on Saturday, June 23, 2017 at the Manning Manse, 56 Chelmsford Road in Billerica, MA.

At 9:30 am Trustee Ruth Ladd led a group of one, Craig Peverly, on an almost 2-mile hike through the Manning State Forest on both sides of Route 129. At 10:30 am President Jeff Manning and Ruth led a group of four intrepid folks on half-hour tour of Manning human and natural history: a long-abandoned amphitheater, bog, the town-managed portion of the State Forest with a stone marker for Warren H. Manning's studio, a lovely stream, the forest itself, and a view of Warren Manning's house on Rt. 129.

Meanwhile, Carolyn McLean, dressed in costume, provided a engaging program with historical information about the Manse, the Manning ancestors, and current family connections. At noon 16 members of the Manning family enjoyed Jon Ryan's Pub fare in the historic Manning Manse. Attendance was down due to conflicts, illness, and other unknown factors.

The annual Manning Association Stockholders Meeting was called to order by President Jeffrey Manning at 1:28 pm. Attendees were: David Warren, Peter and Karin Stuart, Craig and Shirley Peverly, John Cooper, Kathy Nici, Rosemany Whitney, Carolyn Purcell, Jeff Manning, Constance Adams, Carolyn McLean, Catherine Manning, Edward Manning, Jeanne Madden, and Ruth Ladd.

States represented included: CT, MA, NY, and NH.

As Secretary Becky Warren was ill, it was agreed that the minutes would be included in the next Messenger.

Copies of the Treasurer's Report on the Manning Association's finances were distributed by Treasurer Rosemany Whitney. She noted we have more cash on hand this year than last with \$110,762.95 as of May 31, 2018. \$10,000 of that is the tenant's security deposit. The tenant reports business is down so we are not getting the percentage of his income that exceeds a base amount. Rosemary also noted that we needed to repair a vent in the kitchen and will need to repain the Manse. Jeff noted other small repairs that will be needed for the exterior. It was moved, seconded, and passed unanimously to accept the Treasurer's Report.

Rosemary also noted that several people have donated to the Association in some variation of 1696, the year the Manse was built (\$16.96, \$169.60). This is MUCH appreciated!

Kathy Nici said that her family's oral tradition is that Artemis Manning (#1024) was an abolitionist and that the local abolitionist group met at the Manse so it's possible that it was part of the Underground Railroad and perhaps that was the source of the legirons, a photo of which was in the spring Messenger.

Kathy and her sister, Jeanne Madden, also said that their ancestor, Henry Manning from Massachusetts, was wounded in the Civil War, captured, and taken to Andersonville. He escaped by wearing a Confederate uniform but was then captured by the Union army and jailed in Illinois. He was released once he was able to tell them he knew a minister in Illinois who vouched for him.

Ruth Ladd, Editor, asked for submissions for the Messenger. She is also trying to develop a list of all the presidents of the Association so any information is welcome.

Jeff said he is very concerned about the declining membership of the Association and the associated loss of connection with the Manse. He plans to go to the Robinson-Manning Reunion in Lebanon, CT in August to drum up support for our Association. He also noted that he found out about the Association from an article Carolyn McLean had written.

On the status of the Manse, Becky Warren is getting an estimate for painting. Jeff said the tenant wants to put a patio behind the Manse – between the road and the kitchen area. He will show those interested the proposed location following the meeting.

Jeff continues to work towards a Manning Museum at the Manse. He wrote and article and posted it on-line and gave a talk to a group that toured historic sites in the area, including the Manse. The tasks that need to be done include: designing the museum area, adding security, purchasing display cases, labeling artifacts, advertising when it would be open (once a month initially?), and perhaps hiring a docent. There is much to be done so he would welcome anyone interested in working on it. Kathy Nici suggested offering to give tours to school kids and have a handout for them to take home.

There was a discussion of how the Mannings were involved in Harvard University. Shortly after the University was established, a Manning helped raise the money for a building, which included the library. More recently Warren H. Manning's glass plated with landscape architectural drawings were given to Harvard.


